#### <u>Pace SBDC & SBA NYDO Partner on In-Person Small Business</u> <u>Financing Panel</u>

In 2024, the Pace SBDC co-sponsored two <u>in-person Small Business Financing & Networking sessions</u> with the U.S. Small Business Administration's (SBA) New York District Office. Held at Pace University's Lower Manhattan campus.

These events featured lender panel discussions that offered invaluable insights into lender criteria and financing strategies, helping attendees better understand the lending process; as well as dedicated networking sessions, allowing small businesses to connect directly with financial institutions and community lenders from across New York City to explore financing opportunities tailored to their needs.

#### Accounting & Legal Resource Partnerships



#### Pace SBDC & NYSSCPA hosted an Accounting Clinic

The Pace University Small Business Development Center (SBDC) hosted a virtual CPA Accounting Clinic, connecting small business clients with volunteer CPAs from the New York State Society of CPAs for one-on-one consultations. This collaboration provided free guidance on tax filing responsibilities, tax minimization strategies, and other accounting challenges, complementing the no-cost counseling services offered by SBDC advisors. Events like this highlight the SBDC's commitment to fostering impactful partnerships and delivering valuable resources to support New York's small business community.

#### **NELP Remote Small Business Legal Clinic**

In partnership with the Neighborhood Entrepreneur Law Project and Brooklyn Public Library's Business & Career Center, the Pace University SBDC co-hosted a series of Small Business Legal Clinics. These free events connected small business owners with volunteer attorneys for 45-minute consultations, addressing legal needs, offering protection strategies, and providing tailored solutions. The clinic exemplifies the SBDC's commitment to empowering entrepreneurs through valuable partnerships and accessible resources, fostering long-term success in New York's small business community.



### Small Business Website Workday





The <u>Pace University Small Business Development Center</u> (SBDC) hosted several in-person "<u>Website Workdays</u>" for entrepreneurs and small business owners in partnership with the New York Public Library's Thomas Yoseloff Business Center and Brooklyn Public Library's Business & Career Center. Business owners, Pace SBDC Business Advisors and Interns all collaborated to meet and conquer each entrepreneur's individual website goals and challenges.

### PACE SBDC en Español

PACE SBDC & Spanish-speaking clients

In 2024, the Pace SBDC expanded its services to better support Spanish-speaking entrepreneurs through personalized assistance, accessible resources, strategic partnerships, and a <u>website in Spanish</u> with business resources.

#### 1:1 Advisory Sessions:

Bilingual one-on-one sessions were held, which allow us to bring our services directly to the community.

#### **Training Programs**:

Specialized workshops were delivered in collaboration with Qualitas Foundation, NYC Department of Consumer and Worker Protection (DCWP) and NYC Small Business Services (SBS)focused on financial literacy, business development and consumer education.





### Success Stories

#### WE CELEBRATE SMALL BUSINESS WINS

Nose Best Candles, supported by Pace SBDC, won the NYSBDC 2024 Millennial Small Business of the Year for their innovation and growth. With business planning resources and financing like the NY Seed Grant and an Ascendus loan, they expanded to meet rising demand and enter new markets.





Pace SBDC assisted <u>IDEO Skincare</u> in securing a \$150,000 SBA loan through Lendistry, enabling the company to expand inventory and launch a new product. This support facilitated participation in a Barneys New York pop-up during Fashion Week, enhancing retail growth opportunities.

Pace SBDC assisted **Fit N Play Mama** with LLC formation, business banking setup, and marketing strategies, leading to a Neighborhood Business Grant and the recruitment of a Pace University intern to enhance their summer camp and social media presence.





Pace SBDC assisted <u>Liz's Book Bar</u> with business planning and financial projections, leading to SBA-backed financing through Accompany Capital. The bookstore, café, and wine bar opened in July 2024 on Smith Street in Brooklyn, creating seven jobs and exceeding initial financial projections.

#### WE CELEBRATE SMALL BUSINESS WINS

Pace SBDC assisted <u>Kitchen at Cobble Hill</u> with marketing strategies, website enhancements, and securing funding through the Summer Youth Employment Program, resulting in the creation of ten new jobs.





Pace SBDC assisted **Robofun** in refinancing existing debt and securing over \$250,000 in financing through Lendistry, enabling the company to bridge cash flow gaps caused by the pandemic and support growth.

Pace SBDC assisted <u>Leidylicious Cakes</u> with financial projections, advertising, and website development, enabling the opening of their Forest Hills, Queens bakery and the creation of four new jobs.





Pace SBDC supported Paul Melo in acquiring <u>Fort</u> <u>Street Studio</u>, securing financing through the NYC Small Business Opportunity Fund for marketing, a new website, and showroom renovations.
